District 2030 is a commitment to reducing water and energy levels by 50% as well as lowering transportation emmissions. Darwin J Baas (darwin.baas@kentcountymi.gov) talked to us about managing our disgards in the emerging economy. The Recycling and Education Center processed 40 thousand tons of trash this year. Disgards in Kent County increased 4.4% from 2014-2015. Currently Kent County is working towards a circular economy to create sustainability. Their vision is to reduce the amount of trash that goes to landfills 20% by 2020 and 90% by 2030. Please contact Darwin if interested in helping with the green initiatives.

GVSU Study AirB&B Report- GVSU students researched a new impending threat to the lodging industry called Airbnb. Their findings included some advantages to the guests, hosts, and community. Airbnb locations are conveniently located in all cities with a price point for any potential guest. Accommodations are free to list and bring new money into their communities. Disadvantages include permit costs for the host, ADA requirements are non-existent, taxes are not collected, and the community does not always enforce permit regulations. Airbnb locations are on the rise and are a real threat to the lodging industry. Recommendations from the student's research are raising community awareness, develop and execute new marking strategies for hotels, and local government permit enforcement. Recap of Pure Michigan Tourism Conference- Pure Michigan data included 4.6 million trips to Michigan, up ½ million trips from previous year. Tax revenue was up 13 million from 2014 to add 98 million to the economy. The ROI is now
