 - What does she do:
 - Set a diversity values statement helped to make diversity more intentional at EXGR
 - Actively securing meeting and convention business that is diverse in nature.
 - Working on sharing information about diversity with local hotels including but not limited to: speakers, hotel employment, etc.
 - Her 3 goals
 - Enhance community engagement and awareness
 - Enhance diversity & inclusion for the benefit of local & visitor economy
 - Establish a hospitality & tourism management workforce development initiative
 - Work with GRPS to start a pipeline of future hospitality employees

 - Damages productivity
